William L. Prosser Award Winner

It is the pleasure of the AALS Section on Torts and Compensation Systems to announce that Professor Kenneth Abraham, David and Mary Harrison Distinguished Professor of Law, University of Virginia School of Law, is the recipient of the 2024 William Prosser Award.

Professor Abraham's illustrious academic career reshaped the field of tort law. His early work applying modern legal theory to insurance law sparked a revolution in how the law considers torts and compensation systems. Author of 6 books and more than 70 law review articles, Professor Abraham's vision and leadership in the field has culminated into his most recent book, *Tort Law and the Construction of Change: Studies in the Inevitability of History* (2022) (with G. Edward White), which leverages the breadth of his expertise to provide sweeping historical insights into how social change and tort law interact.

Professor Abraham served for more than 20 years as a Member of the ALI Council, as an advisor to the ALI's Restatement of Torts (Third), and was the senior advisor to the Restatement of the Law of Liability Insurance. He is a sought-after expert witness, has served as arbitrator for the Dalkon Shield Claimants Trust, and is well-recognized as an award-winning teacher.

The AALS Section on Torts and Compensation Systems is grateful to Professor Abraham for not only personally contributing so much to our understanding of tort law, but also for his tireless investment in the future through his mentorship of students, lawyers, and new scholars. Professor Abraham's work exemplifies the life-long commitment to refining theory and doctrine, engaging in outstanding teaching, and selfless service that the Prosser Award seeks to recognize.

2025 Prosser Award Nominations

At the 2025 Annual Meeting, the Torts and Compensation Systems Section will once again present the William L. Prosser Award to law professors who have made outstanding contributions of scholarship, teaching, and service in tort law. Any law professor is eligible to nominate another law professor for the award.

The 2024 Prosser Award recipient was selected by the members of the Executive Committee of the Torts and Compensation Systems Section, based on the recommendation of an appointed special selection committee.
