Bylaws of the Section on Communication, Media & Information Law

Amended April 2019

Article I, Name and Purpose

Section 1. Name. This Section shall be known as the Section on Communication, Media & Information Law.

Section 2. <u>Purpose</u>. The purpose of this Section is to promote the communication of ideas, interests, and activities among members and to make recommendations on matters of interest in the teaching and improvement of the law relating to communications, media and information.

Article II, Membership

Section 1. Membership.

(a) Membership in the Section is open to any faculty person of a law school that is a member of the Association of American Law Schools (hereinafter referred to as AALS) and to Canadian Associates.

(b) Associate membership is open to others who are interested in the law of mass communications.

Section 2. Privileges of Members.

- (a) Regular members may vote in person at all Section meetings.
- (b) Associate members may participate in the programs, meetings and activities of the Section, but may not vote or hold office in the Section.

Article III, Officers, Committees

Section 1. Officers. The officers of this Section are the chairperson, chairperson-elect, secretary, and treasurer. The chairperson-elect, the secretary and the treasurer shall be elected at each annual meeting and shall qualify by acceptance. The chairperson-elect shall succeed to the office of chairperson at the close of the next annual meeting. An officer shall serve until his successor has been elected and qualified.

Section 2. The Executive Committee.

- (a) The Executive Committee consists of the chairperson, chairperson-elect, secretary and treasurer of the Section, and at least four other members elected annually.
- (b) The Executive Committee shall act in the interval between annual meetings and may create standing and special committees.

Section 3. Standing Committees.

- (a) The standing committees of the Section shall be (1) the NominatingCommittee, (2) Program Committee, and (3) the Committee on Special Projects.
- (b) The standing committees shall have such duties as are described by the Executive Committee.

Article IV, Nomination and Elections

Section 1. <u>Nominations</u>. The Nominating Committee for the subsequent year shall be appointed at or immediately following the annual meeting. The Nominating

Committee shall consist of at least three members of the Section and shall include at least one past chairperson of the Section. The Nominating Committee shall receive and consider suggestions of persons to serve as officers for the Section and shall report a slate of nominees to the Section for election at the business meeting of the Section at the annual meeting of the AALS.

Section 2. <u>Elections</u>. The officers of the Section shall be elected at the annual meeting. Nominations shall be received from the Nominating Committee and from the floor. Elections may be by voice or secret ballot, as the chairperson determines.

Article V, Duties of Officers

Section 1. <u>Chairperson</u>. The Chairperson of the Section shall preside at all meetings of the Section and of the Executive Committee. The Chairperson shall present at each annual meeting of the AALS a report of the Section for the prior year and shall be responsible for the program of the Section. The Chairperson shall appoint the members of standing and special committees.

Section 2. <u>Chairperson-Elect.</u> The Chairperson-Elect of the Section shall assist the Chairperson, as the Chairperson may request, and shall perform the duties of the

Chairperson during absence or disability of the Chairperson. If the office of the Chairperson becomes vacant, the Chairperson-Elect shall succeed to the Office of Chairperson.

Section 3. <u>Secretary</u>. The Secretary of the Section shall keep the minutes of the proceedings of the Section, the Council and the Executive Committee and shall perform such other duties as the Chairperson may request.

Section 4. Treasurer. The Treasurer of the Section shall be responsible for financial matters for the Section, at the Chairperson's request.

Article VI, Amendments

Section 1. <u>Amendments.</u> These bylaws may be amended at the annual meeting of the Section by a majority of the regular members of the Section present and voting. The amendment takes effect after it has been approved by the Executive Committee of the AALS.
