Administrative agencies play an important role in many aspects of disability law, including employment, education, housing, and health care, to name a few. Many federal agencies are in the process of updating or issuing significant new disability-related regulations. At the same time, the administrative state has come under fierce attack, especially with the Supreme Court's decision to overrule Chevron. Panelists will discuss topics such as significant new regulatory activity in education and health care, potential future regulatory activity in a broad range of areas, and the impact of the Supreme Court's rulings.

The 25th Anniversary of Olmstead

In 1999, the Supreme Court held in *Olmstead v. L.C.* that the unjustified segregation of persons with disabilities violates the Americans with Disabilities Act. *Olmstead*, and the enforcement of its integration mandate, has enabled thousands of individuals to live in their homes and communities instead of in an institution, providing them with greater independence, autonomy, and opportunities to participate in their community. The 25th anniversary of this landmark decision provides an opportunity to reflect on *Olmstead's* impact and explore the creative new ways it has been used recently, particularly by the U.S. Department of Justice.
