# Letter from the Chair

Dear Section Members,

As early as the hiring stage, individuals applying for an academic job in a law school are greeted with an unaccommodatina environment. Our hiring conference is notoriously difficult to navigate, even for individuals without mobility issues. For the lucky individuals who escape being shut out of the law school academic market altogether (despite our hiring process), unbending expectations of frequent travel and standing while presenting as part of the promotion and tenure processes are not always compatible with living with a disability. Not to mention that the AALS's annual meeting lacks a thorough, systematic structure for providing accommodations for our colleagues with all types of disabilities.

The result is that many of our colleagues living with a disability are unable to participate fully (if at all) in our Association's annual meeting.

Current and former members of our Executive Board are working diligently to ameliorate this unfortunate reality within the AALS. In particular, we have undertaken two initiatives to support the inclusion of our colleagues.

First, during the annual meeting, we will meet with AALS leadership to discuss the implementation of permanent oversight structures at all AALS-sponsored events to ensure that individuals with disabilities have access to the support and accommodations they need.

Second, we will have an informational session for a new affinity group for AALS members with disabilities and their allies at this year's annual meeting. We hope you can join us at 5:30pm on January 2, 2020 in Virginia Suite B for this formative event. For those of you who are unable to attend—especially those of you who are unable to attend due to the physical realities of your disability we are committed to making this affinity group virtually inclusive.

We also hope you can join us earlier in the afternoon on January 2 at 1:30pm for our annual section program, entitled, "Reconsidering Disability Benefit Programs," in Maryland Suite C. The program will explore current challenges facing social benefit programs offered to individuals facing physical and mental limitations, with an eye towards how to innovate, expand, and improve these programs in the future. I am delighted to be moderating a panel of incredible speakers, who include lawyer and activist Matthew Cortland, Dr. Jennifer Erkulwater (author of Disability Rights and the American Social Safety Net), and Professor Katherine L. Moore.

Finally, if you are interested in becoming more involved with any of our section's initiatives, I encourage you to contact me and, if possible, to attend the Executive Board meeting before our section program. With the active participation of our section membership, we are confident that we can bring meaningful, more inclusive change to the AALS.
